Vaccine Information

Gunnison County reports 9,299 fully vaccinated residents on 5/17/21. Additionally, we expect more fully vaccinated individuals from the CDPHE mobile clinic to be included in this tally – pushing the total closer to 9,500. Unfortunately, the numbers from the CDPHE clinic were not available for our Monday numbers update.

Don't wait walk-in. There is a walk-up clinic on 5/27/21 at the Fred Field Center in Gunnison. This clinic will run from 4pm-5:30pm and will have Pfizer, Moderna, and Johnson & Johnson vaccine available.
